## AWARD

The dispute between the parties having been referred for determination to the Lok Adalat and the parties having compromised / settled the case / matter, the award is hereby passed in terms of settlement as follows:

### TERMS OF SETTLEMENT

Settlement has been arrived between the petitioner(s) and the respondent(s). Accordingly, the respondent(s) has agreed to pay a compensation of Rs. 17,17,000/- (Rupees Seventeen Lakhs and Seventeen Thousand Only) to the Petitioners. P1 is entitled to the share amount Rs. 10,00,000/-. P2 is entitled to the share amount Rs. 4,00,000/-. P3 is entitled to the share amount of Rs. 3,17,000/- .

The respondent shall transfer the Award Amount into the Bank Account of the Petitioner(s) directly within one month from the date of this award. If any minor award amount is involved, it shall be transferred by way of fixed deposit into the Bank Account of the minor. In case of award amount of minor is involved, it is the responsibility of the Bank to convert into the fixed deposit and it shall be disbursed after attaining majority of the minor.
