AWARD

TERMS OF SETTLEMENT

Settlement has been arrived between the petitioner(s) and the respondent(s). Accordingly, the respondent(s) has agreed to pay a compensation of Rs. 7,72,500/- (Rupees Seven Lakhs Seventy Two Thousand and Five Hundred only) to the Petitioner.


