TERMS OF SETTLEMENT

Settlement has been arrived between the petitioner(s) and the respondent(s). Accordingly, the respondent(s) has agreed to pay a compensation of Rs. 4,80,000/- (Rupees Four Lakhs and Eighty Thousand only) to the Petitioner.
