AWARD



TERMS OF SETTLEMENT

Settlement has been arrived between the petitioner(s) and the respondent(s). Accordingly, the respondent(s) has agreed to pay a compensation of Rs. 7,20,000/- (Rupees Seven Lakhs and Twenty Thousand only) to the Petitioner.

The respondent shall transfer the Award Amount into the Bank Account of the Petitioner(s) directly within one month from the date of this award. If any minor award amount is involved, it shall be transferred by way of fixed deposit into the Bank Account of the minor.
