Accused Munnalal, Satishpal and Devendra stated that they wish to plead guilty for the offence under section **323, 504,506 IPC**. Accused given time to think over the plea of guilt. Accused reiterated that they wish to plead guilty to the offence with which they have been charged.

This court is satisfied that the plea of guilt has been made voluntarily. Accused are thereby held guilty and convicted for the offence punishable **under section 323, 504,506 IPC**.

The accused stated that they are confessing the crime and that they are poor and come from same family and all are brothers. The above case is very old and they wish to confess to the charges owing to their circumstances and feel apologetic and they will never repeat the offence in future. With other statements the accused have prayed for leniency on the aspect of sentence.

Heard and perused the record. Accused Kamal Singh s/o Bhuri Singh has died and his death certificate is present on record and the case stands abated against him. The accused Munnalal s/o Bhuri Singh, and Satish alias Satishpal s/o Bhuri Singh and Devendra alias Raja s/o Bhuri Singh All R/o PS Narkhi **are** hereby convicted for the offence **under sections 323,504,506 IPC**. Considering the confession of the accused before the court and their special circumstances, the accused are hereby released under **Section 4 Probation of offenders Act** on probation for **two months**. The accused are directed to maintain peace and good conduct for this period and they will not repeat the offence. They will furnish a personal bond each to the sum of **Rs. 10,000/-** before the probation officer within a week. DPO will submit a timely report before this court. In case, the accused fail to maintain peace and good conduct during the period of probation, then they can be taken into custody again and punished. A copy of this order be sent to DPO for necessary action. All previous bonds, for and on behalf of accused stand discharged. File be consigned to record room after due compliance.
