DECREE

1	That the suit be and the same is hereby decreed
2	That the defendant is hereby directed to pay a sum of Rs.13,36,635/- to the plaintiff and also directed to pay interest at the rate of 24% p.a. for the principal amount of Rs.11,00,000/- from the date of plaint i.e. 29.11.2021 till the date of Judgment and thereafter at the rate of 6% p.a. from the date of Judgment till the date of realization.
3	That the defendant is hereby further directed to pay a sum of Rs.51,819/- to the plaintiff being the cost of the suit.
