ORDER

Petition filed by the petitioner U/s. 483(1)(b) of BNSS to modify the condition imposed in CrImp.No. 03/2026 on 16.02.2026.

1. The Averments in the petition:

The Petitioner was charged U/s. 302, 404 r/w 201, 120(B) of IPC by this Court and that, The Petitioner was granted bail in CrI.M.P.No. 03/2026 in Cr.No.68/2011, dated:30.02.2026 by this court, on condition that the Petitioner/Accused shall execute a bond for a sum of Rs.10,000/- with two sureties each for a like sum to the satisfaction of this Court and therefore, the Petitioner should report before this Court on every working day at 10.30 a.m. until further Orders.

2. The Petitioner has duly complied and followed the said condition from 16.02.2026 to till date. The Petitioner could not be able to work, due to the reason that, he is traveling from his place and to this Court. Unless the Petitioner goes to

work, he cannot earn money to spend even the Bus fare, in order to report before this Court. The Petitioner undertakes to appear before this Court for future hearings without fail and therefore, the Petitioner has come forward with this Petition to modify the condition or to relax the Condition imposed on him.

3. Point for Determination:- On perusal of the case records, the Petitioner has complied the order of this Court in CrI.M.P.No.3/2026 dated 16.02.2026 and he has reported before this Court from 16.02.2026 to 27.03.2026. Since the Petitioner has complied the order of this Court, without any deviation, this Court is inclined to modify the condition imposed on him.

In the result, the Petitioner is directed to report before this Court, once in 15 days on the 1st working day at 10.00 a.m, until further orders and the condition is modified.
