Dispute in brief: The Claimants/Applicants claims from the Respondents/  
Opponents a sum of Rs. 22,00,000/- As compensation for the injury caused to him/ ~~death~~ of  
~~one~~ in a Motor Vehicle Accident.

We, that is Thiru. P. Vasudevan.....Advocate for Petitioners and

Ltd., in the above said mcop have arrived at the compromise to settle the matter as follows:

Terms of Settlement

1. Respondents/Opponents/Insurance Company Ltd., shall pay a sum of Rs. 2,30,000/- (Rupees TWO LAKH THIRTY THOUSAND ONLY only) as compensation Claimants/Applicants.

1. The ...Respondents/Opponents/Insurance Company Ltd., shall deposit the entire award amount within 30 days from the date of receipt of the award, by **direct transfer** through NEFT or RTGS in the Savings account No; 428 349 138<sup>17</sup> in the state Bank of India, Arni Branch ( IFSC Code No:SBIN0000808) standing in the name of "~~ADJ~~ **ADJ** Court , Arni".

2. The Claimants/Applicants shall be entitled to withdraw the entire amount immediately after the deposit in to the Tribunal as stated above.

3. In default <sup>rd</sup> Respondents/Opponents/Insurance Company Ltd., shall pay the interest for the decree amount at the rate of 7.5% per annum from the date of default till the date of payment.

4. Disbursement of the compensation amount will be made to the Claimants/Applicants, only by way of direct credit to the bank account of the Claimants/Applicants through NEFT or RTGS.

5. The share amount of Minor Claimant/Applicant with proportionate interest shall be invested in fixed deposit in a Nationalized Bank till the minors attain age of majority. The guardian/Nest friend of minor Claimant/Applicant is permitted to withdraw the interest accrued on the fixed deposit of minor Claimant/Applicant once in 3 months for the benefit of the minors and in such case, the interest shall be paid by direrct transfer to the bank account of minor Claimant/Applicant by NEFT or RTGS.

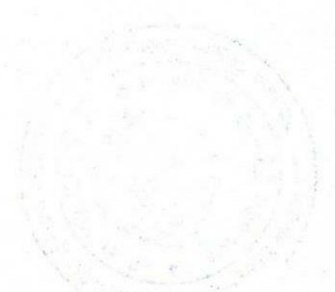
