Nature of Suit :

The plaintiff has filed the suit as against the defendant, directing the defendant to pay the suit sum of Rs.11,02,875/- (Rupees Eleven Lakh Two Thousand Eight Hundred and Seventy Five only) being the amount due under the promissory note with subsequent interest at the rate as may be fixed by this Court, from the date of plaint till the date of realization and for cost of the suit.

Date of Plaint : 14.03.2019

Cause of action : for the suit arose on and from 18.07.2017, 24.02.2019 at State Bank Officer Colony, Crawford, Tiruchirappalli District within the jurisdiction of this court.

This suit coming before me on 06.06.2026 for final hearing, in the presence of Thiru. M. P. V. Udayakumar, Advocate for the Plaintiff and of Thiru.S.Balasubramanian, Advocate for the Respondent and upon perusing the plaint, written statement, evidence and documents and upon hearing the arguments of both sides and having stood over for consideration, this Court doth order and decree as follows :

- that the suit be and the same is hereby decreed with cost in favour of the plaintiff;
- that the defendant is hereby directed to pay the suit sum of Rs.11,02,875/- (Rupees Eleven Lakh Two Thousand Eight Hundred and Seventy Five only) together with subsequent interest on the principal amount at the rate of 9% p.a. from the date of plaint till the date of decree and thereafter at 6% p.a. from the date of decree till the date of realization;
- that the defendant do pay a sum of Rs.43,298/- to the plaintiff's being the cost of the suit.
