Petition dated: 09.03.2026 u/s 483 of BNSS praying to enlarge the petitioner on bail

This petition coming on this day for hearing before me having the petition filed by the petitioners Counsel M/s A. Thirumalai, K. Raja, D. Jothi, R. Vetrivel, M. Sharmila, S. Sathishkumar, the respondent police through the Public Prosecutor, and upon hearing the arguments of both sides, perusing the reply of the Public Prosecutor for the State/Respondent and perusing the records and material and hearing both sides, this court made the following:-

ORDER

Heard arguments of both side. Records perused. Petition filed u/s 483 of BNSS seeking to release the petitioner who was remanded on 08.03.2026 in Crime No.32/2026 on the file of Thiruvelangadu police station registered for the offence u/s 296(b), 351(2), 309(4), 324(4), 326(f) of BNS r/w 4 of TNPPDL Act and section 66(C) of IT Act.

The learned counsel for the petitioner argued that, petitioner is innocent and they are in no way connected with the alleged offence, they were not at all present in the place of occurrence, the matter has been compromised, even the defacto complainant is present to file an affidavit that he has no objection to grant bail, there is no injury to anyone during the alleged occurrence, no property was damaged, he is in judicial custody for the past 9 days, petitioner is ready to cooperate for investigation and will abide by any condition, therefore prayed for granting the bail.

Notice given to concerned police and reply received. The learned Public prosecutor argued that on 05.03.2026 at about 12.15 PM, when the defacto complainant was in his house, the accused came to the house and called him out of the house and when the defacto complainant's mother opened the door, the petitioner along with other accused trespassed into the house and threatened to kill the defacto complainant and damaged the two wheeler of the defacto complainant's son bearing Reg.No. TN20DK3818 causing damage to the value of Rs.50,000/- and also, snatched the defacto complainant's phone and transferred Rs.19,000/- to their account through G-Pay, and demanded to give Rs.1 lakhs, and escaped, based on the complaint, FIR was registered u/s 296(b), 351(3), 309(4), 329(4), 326(f) r/w 4 of TNPPDL Act and section 66(C) of IT Act and petitioners were arrested on 08.03.2026 , and the investigation is pending.

The petitioner states in this petition that there is no similar bail petition is pending before any other Court including Hon'ble High Court, Madras and the respondent has also not stated as to pending of any bail petition before Hon'ble High Court, Madras in this case. Hence, this Court considers that there is no impediment to entertain this petition and pass orders on merits.

As per the reply of the learned Public Prosecutor, investigation is pending in preliminary stage and the alleged offence is serious in nature.

Therefore, on considering

- (i) grave nature of offence
 - (ii) investigation is pending
 - (iii) premature stage and the first remand period itself is not completed,
 - (iv) serious accusation of offence as against the petitioner u/s 326(f) of BNS and section 4 of TNPPDL Act
 - (v) value of the property allegedly damaged and amount involved,
 - (v) and also considering other facts and circumstances,
- this Court is not inclined to grant bail to the petitioner.

In the result, this petition is dismissed.
