DECREETAL ORDER

1. That the petition be and the same is hereby partly allowed
2. That the respondent be and is hereby directed to pay Rs.20,000/- (Rupees Twenty Thousands only) to the petitioner and her minor children towards their monthly maintenance from the date of application till date of disposal of main Original Petition
- 2 That the respondent be and is hereby directed to pay the monthly maintenance to petitioner on or before 10th day of every English Calendar Month
- 3 That there is no order as to costs of the petition.
