Present: Sh. Amarnath Jaiswal, Ld. Counsel for accused Sumit Fagna alongwith accused.

The ld. Counsel for accused Sumit Fagna has moved an application seeking cancelation of NBWs issued against him at the time of first call today on the ground that his motorcycle had broken down and he could not reach this Court on time.

Perusal of record reflects that the accused did not appear before this Court on last date of hearing i.e. 14.07.2025 as well. There is no mention of the grounds for such non appearance.

It is submitted by the accused that he could not appear before this Court on 14.07.2025, since his mobile phone

was stolen on 13.07.2025. There is no copy of FIR/complaint filed by him regarding the said fact.

There is no merit in the submissions made on behalf of the accused regarding his non appearance on last date of hearing. The application is hereby dismissed. The accused Sumit Fagna is taken into custody.

The personal bond amount stands forfeited to the State and let the same be deposited on or before the NDOH.

Let the warrants of attachment be issued against the surety for accused Sumit Fagna through IO/SHO concerned.
