**ORDER**

This Petition filed U/S 151 CPC seeking permission to scrap the evidence of PW1.

Heard both sides. Records perused. Petitioner filed petition to eschew the evidence of PW1. Petitioner side submitted that PW1 died on 13.02.2024 hence it is necessary to scrap the evidence of PW1. Hence he prays to allow this petition. Counsel for R7 to R10 submitted as this petition filed to drag on the proceedings and the petition was very vague and untenable one. Hence counsel for R7 to R10 prays to dismiss this petition.

Records perused. Petition filed by the Petitioner seeking permission to to eschew the evidence of PW1 who died on 13.02.2024. This case is pending in the stage of PW1 chief continuation. Since PW1 died on 13.02.2024 it is necessary to scrap the evidence of PW1. Considering the fact and circumstances for proper adjudication of the case, this petition has to be allowed.
