This petition is coming on 26.05.2026 for final hearing in the presence of M/s. Mr.M.Jayaseelan, Mrs.J.Sasilie, Mr.N.Silambarasan, Mr.J.Hemanth, Mr.G.Thirumalai counsels for petitioners and The Assistant Public Prosecutor for the Respondent, after hearing both sides and perusing the material records this Court deliver the following.

ORDER

1. This Petition is filed for bail Under section 480 of BNSS and the petitioners was arrested by the respondent for the offence under section 126(2), 296(b), 115(2), 118(1), 308(2), 351(3) BNS.
2. Notice given to respondent and the reply received. The petitioners are in judicial custody from 20.05.2026 for alleged offence under section 126(2), 296(b), 115(2), 118(1), 308(2), 351(3) BNS.
3. The learned counsel for the petitioners argued that the petitioners are innocent and

falsely implicated in this case and the petitioners are ready to furnish sufficient sureties. Hence, he prayed to allow the bail application.

4. The respondent filed reply and objected to release the accused on bail, and stated that if he released on bail, he may indulge in same kinds of offences. Hence, prayed for dismissal of bail application.

5. Both side records perused. On perusal of records, it is seen that the accused Vijay (a) Puppy Vijay S/o. Kumar and Jayavanan (a) Gnanam S/o. Rathinam arrested and remanded to judicial custody on 20.05.2026 for the past 6 days. Considering the stage of investigation, nature of offence, duration of the accused in prison, this court is inclined to **grant bail to the accused** with condition, accordingly this bail application is allowed.

i. The petitioners shall execute a bond for **Rs.10,000/-** together with two sureties each for like sum and both sureties affixed their photo and left thumb impression in the surety bond.

ii. The petitioners shall appear and sign before the concerned respondent police station daily at 10.00 AM everyday for 30 days, without fail, from the date of release from prison.

iii. Further he shall not abscond either during investigation or trial.

iv. The sureties obtain a copy of their Aadhar card or bank pass book to ensure their identity.

v. The petitioners shall not commit an offence, similar to the offence of which he is accused, or suspected.

vi. The petitioners shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case.

vii. The petitioners and his sureties shall not change the mobile number, address without the permission of this court.
