Petition dated 05.03.2026 U/s.482 BNSS to grant anticipatory bail to the petitioner.

This petition is coming on this day for hearing before this court in the presence of **Thiru.M.Mariya Mathan Raja**, Advocate for the Petitioner and **Thiru.M.P.K.Maruthappan**, Public Prosecutor for the Respondent/complainant and upon hearing both sides, this Court passed the following :

ORDER

Petitioner/accused seeks anticipatory bail for the alleged offences under section 329(4), 324(4), 296(b), 115(2), 351(3) of BNS and section 4 of TNPHW Act registered by the Respondent police.

The learned counsel for the petitioner would submit that this petitioner profession is selling two wheeler and due to business motive the defacto complainant son giving false information about this petitioner in order to cause loss to the business and the injured in this case was discharged from the hospital and this petitioner has no previous case and the petitioner is ready to abide any condition and prays to grant anticipatory bail to the petitioner herein.

The learned Public Prosecutor submitted that the defacto complainant son

running a finance company and received the loan and the was not repaid and this petitioner identified the defacto complainant son wordy quarrel arose and attacked the defacto complainant son caused injuries and the injured discharged from the hospital and this petitioner has no previous cases.

Heard. The submissions of both sides considered. Considering the facts that the injured in this case was discharged from the hospital and these petitioners have no previous case and other facts and circumstances of this case this court is inclined to grant anticipatory bail to the petitioner.

In the result this petition is allowed subject to following conditions.

- i) That in the event of arrest of the petitioner by the Respondent/police or on his surrender before the learned Judicial Magistrate, Tenkasi within 15 days from the date of this order and on such arrest or surrender the petitioner is ordered to be enlarged on anticipatory bail on his executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties for a like sum each to the satisfaction of the learned Judicial Magistrate, Tenkasi. **If the petitioner/accused is not surrender within 15 days from the date of this order this Anticipatory bail shall stands cancelled automatically:**
- ii) The sureties shall affix their photographs and Left Thumb Impression in the surety bond and the sureties shall produce a copy of his Aadhaar card or Solvency Certificate or Bank pass book to ensure their identity.
- iii) **That the petitioner shall report and sign before the Respondent P.S daily once at 10.00 A.M for one month.**
- iv) **The Petitioner has to furnish his Mail ID and Phone number before the trial court at the time of executing bond.**
- v) The petitioner shall make available himself for interrogation as and when required by the investigation Officer.
- vi) The petitioner shall not tamper the witness or hamper the evidence in any manner either during investigation or Trial.
- vii) The petitioner shall not abscond either during investigation or Trial.
- viii) That on breach of any of the aforesaid conditions, the Investigation Officer shall report to the learned Magistrate / Trial Court and shall take appropriate action against the petitioner in accordance with law.
- ix) If the accused thereafter absconds, a fresh FIR can be registered U/S.269 BNS.
