Petition dated 07.03.2026 U/s.483 BNSS to grant bail to the petitioner.

This petition is coming on this day for hearing before this court in the presence of Thiru.S.Bala Sankar, Advocate for the Petitioner and Thiru.M.P.K.Maruthappan, Public Prosecutor for the Respondent/complainant and upon hearing both sides, this Court passed the following :

ORDER

The Petitioner/accused was arrested and remanded to judicial custody on 06.03.2026 for the alleged offences punishable under sections 329(4), 296(b), 75(1), 75(2), 351(3) of BNS and section 4 of TNPHW Act registered by the respondent police, seeks bail.

The learned Counsel for the petitioner/accused would submit that due to love affairs backdrop the whole occurrence taken place and this petitioner has been falsely implicated in this case and this is purely put up case only and no one sustained injury in this case and this petitioner is undergoing incarceration for the past 5 days and prays to grant bail to the petitioner subject to any conditions.

The learned Public Prosecutor would submit that the allegation against this petitioner is that the defacto complainant and this petitioner loved each other and when the defacto complainant has known about the character of the petitioner, she break up the love between them and hence this petitioner trespassed into the house of the defacto complainant and abused her with filthy language and sexually tortured her and also threatened her with dire consequences and this petitioner is having 2 previous cases in Manur P.S. and Alwarkurichi P.S. and the investigatin is pending.

Heard. Records perused. The submissions of both sides were considered. The allegation against this petitioner is that the defacto complainant and this petitioner loved each other and when the defacto complainant has known about the character of the petitioner, she break up the love between them and hence this petitioner trespassed into the house of the defacto complainant and abused her with filthy language and sexually tortured her and also threatened her with dire consequences. Considering the fact that no one sustained injury in this case and this petitioner is undergoing incarceration for the past 5 days and the nature of offence and the antecedents of the petitioner and other facts and circumstances, this court is inclined to grant bail to the petitioner.

In the result this petition is allowed subject to following conditions.

- i) The petitioner is ordered to be enlarged on bail on executing his bond for Rs.10,000/- (Rupees Ten Thousand only) with two sureties for a like sum each to the satisfaction of the learned Judicial Magistrate, Tenkasi.
- ii) The sureties shall affix their photographs and Left Thumb Impression in the surety bond and the sureties shall produce a copy of their Aadhaar card or Solvency Certificate or Bank pass book to ensure their identity.
- iii) **The petitioner shall stay at Madurai and report and sign before the Thallakulam P.S daily once at 10.00 A.M until further orders.**
- iv) **The Petitioner has to furnish his Mail ID and Phone number before the trial court at the time of executing bond.**
- v) The petitioner shall make available himself for interrogation as and when required by the investigation Officer.
- vi) The petitioner shall not tamper the witness or hamper the evidence in any manner either during investigation or Trial.
- vii) The petitioner shall not abscond either during investigation or Trial.
- viii) That on breach of any of the aforesaid conditions, the Investigation Officer shall report to the learned Magistrate / Trial Court and shall take appropriate action against the petitioner in accordance with law.

- ix) If the accused thereafter absconds, a fresh FIR can be registered U/S.269 BNS.
