DECREE

1. that the suit be and the same is hereby decreed.
2. that the defendants are directed to pay jointly and severally a sum of Rs.13,00,000/- (Rupees Thirteen Lakhs only) to the plaintiffs from and out of the estate inherited by them from the deceased Muthu, together with interest at the rate of 12% from the date of suit till the date of decree and at the rate of 6% from the date of decree till the date of realization.
3. that the plaintiff is entitled to recover the cost of Rs.59,979/- from the defendant.
