ORDER BELOW EXH.-1

The applicant viz. Jaychandra Dharamchandra Mishra has filed application for releasing his mobile handset Lenovo Tablet made, I.M.E.I. No.869432026988027 and 869432026988019. The Investigating Officer, gave no objection for handing over the seized mobile handset in favour of the applicant. Ld. A.P.P. submitted that the mobile handset will require for identification during the trial. It is prayed that, necessary order be passed.

2] Heard both sides.

3] During the investigation mobile handset is recovered. It also appears that, as per the report lodged by present applicant a crime bearing No.629/2019, P.U.S. 379 of I.P.C., is registered against unknown accused, at police station, Mumbai Central. In support of application applicant placed on record copy of Asset Handover Form of DOMS Industries Pvt. Ltd. Issued in favour of applicant, on 01/06/2017. Applicant also filed copy of his Aadhar Card, F. I. R. and copy of box having details of said mobile/Tab. No purpose would be served by keeping the mobile handset by police station itself. Applicant is entitled for getting custody of mobile handset. Therefore, the order :

ORDER

- 1] The seized mobile handset Lenovo Tablet made, I.M.E.I. No.869432026988027 and 869432026988019, be given to the applicant viz. Jaychandra Dharamchandra Mishra, R/o.- 1/39, Vimla Devi Chawl, Kajupada Road, Poisar, Kandivlai (E), Mumbai, on indemnity Bond of ₹ 12,000/- (Twelve Thousand), which is to be executed before Investigating Officer of Railway Police Station, Mumbai Central, on following condition :
 - (a) The applicant shall produced the mobile handset, as and when required.
 - (b) The applicant shall not transfer or alienate the seized mobile handset till the decision of the main case.
 - (c) The applicant shall not change the nature of the seized mobile handset by any manner till the decision of the main case.
- 2] The Investigating Officer shall furnish the Indemnity Bond alongwith the final report / chargesheet, in this Court.
- 3] This proceeding be kept with the remand papers of C. R. No.629/2019 of Railway Police Station, Mumbai Central, Mumbai for merging the same in the main case after filing the chargesheet, if any.
