This suit is coming up before this court for hearing today (05.08.2024) in the presence of Thiru.P.Murugesan, Advocate for the plaintiffs and Thiru.S.Sankara Subramanian, advocate for D1, D2 and Thiru.K.Suresh Prabakaran, advocate for D3, D4 and Government Pleader for D5, D6. D1 to D4 were called absent set exparte. No representation on the plaintiffs side. Plaintiffs called absent and upon perusing the case records, this court delivered the following.

Judgment

This suit is for declaring the appointment of 1st defendant as secretary of the Sri Murugan Vidhayalayam as null and void and declaring that the plaintiffs and defendants 2, 3 and 4 are the educational agency of the school namely Sri Murugan Vidhayalayam and in consequence thereof granting permanent injunction restraining the 1st defendant in any way interfering with the administration and management of Sri Murugan Vidhayalayam and its properties and granting permanent injunction restraining the 1st defendant from in any way either claiming himself as educational agency of Sri Murugan Vidhayalayam or constituting any school committee of Sri Murugan Vidhayalayam and granting permanent injunction restraining the 1st defendants 5 & 6 from in any way either approving the claim of 1st defendant as educational agency of Sri Murugan Vidhayalayam or from approving constitution of school committee proposed by defendants 1 & 2 from 01.01.2018 and for future period and granting mandatory injunction directing the defendants 5 & 6 to continue to administer and manage the school Sri Murugan Vidhayalayam till adjudication as to educational agency of a school Sri Murugan Vidhayalayam and for costs.

P1, P3 to P7 called absent. No representation. APC was returned on 31.07.2024. APC not represented. From 10.03.2023 APC pending. APC to be filed within 14 days. In spite Amendment not carried out. Hence suit is dismissed for default.
