It is true to say that I have not treated the petitioner and only assessed the disability. It is true to say that only on the basis of discharge summary, clinical examination and medical records I have assessed the disability. It is false to say that personally I don't know about the injuries sustained by the petitioner. It is false to say that the the injuries sustained by the petitioner of K wire of the left on 13.02.2022 will heal within 3-4 weeks from the date of treatment. It is further false to say that after treatment the fractures sustained by the petitioner will heal within 2-5 weeks. It is false to say that the injuries sustained by the petitioner to the right distal radius will heal within 6-8 weeks after treatment. It is false to say that the injuries sustained by the petitioner underwent ORIF with plate and screws as on 11.04.2022 will heal within 4-6 weeks. After operation the petitioner has taken followup treatment. It is false to say that if rehabilitation is done properly then implants mentioned in para 5 of my affidavit will nor arise. The cause of bilateral wrist deformity is due to mall union. It is false to say that the bilateral wrist deformity is may be due to tobacco, obesity and other medical conditions. It is true to say that I have not furnished central govt., guidelines along with my affidavit. The disability assessed by me to the petitioner is based on clinical examination. It is false to say that the clinical examination

done by me to assess the particular disability is without following the guidelines of central govt., It is true to say that I have not mentioned in my affidavit the yardstick used to assess the disability. It is false to say that I have assessed false disability in higher side in order to help the petitioner. It is false to say that the medical and future medical expenses stated by me in the affidavit of Rs.90,000/- is on higher end. It is false to say that the petitioner will be alright without any disability over a period of time. It is false to say that as I have not treated the petitioner I cannot assess the disability. It is false to say that in order to help the petitioner to get more compensation I have assessed the disability on higher side and deposing falsely.
