Present: Complainant in person.
Accused in person.
Sh. Rajat Sang, Ld. Counsel for accused through VC.

NBWs issued against the accused **received back unexecuted**. However he was contacted on phone and he assured that he will appear before court. Today accused has appear before court.

Perusal shows that process u/s 82 Cr.P.C was issued against the accused and was subsequently stayed.

An application moved on behalf of accused for cancellation of NBWs issued against the accused. Same is considered.

In view of the facts mentioned in the application, NBWs issued against the accused Sompal stands stayed till the next date of hearing, subject to cost of Rs. 1,000/- to be paid to NGO for rescuing animals namely “**Karanpuri Foundation through MILAAP Link**”. Accused is directed to file the cost receipt by 1 p.m., at request.

Accused submits that he resides at **H. No. C-3/502, Tulip Ace, Sector 89, Pataudi Road, Gurgaon and his no. is 9891091980.**

Accused/applicant has shown remorse before the court. He undertakes to be present on each and every date of hearing.

Complainant submits that there is no possibility of settlement.

Perusal shows that matter was pending for adjudication on application u/s 311 Cr.P.C filed on behalf of accused. Arguments on the same were heard by the Ld. Predecessor. Parties are directed to address afresh.

Be put up for arguments and furnishing of cost receipt at **01:00 p.m.**

Despite repeated calls none has appeared on behalf of accused. Cost receipt has not been filed despite taking time and accused has left without any intimation. Accordingly, due to disobedience of court's order, the cost now stands enhanced to Rs. 2,000/- to be paid to NGO for rescuing animals namely "**Karanpuri Foundation through MILAAP Link**". Receipt of same be filed on NDOH.

Ld. Counsel for complainant submits that he has never received the copy of any such application. Perusal of record shows that no such application has been filed by the accused. On 04.03.2025, accused had undertaken to file the physical copy of the application along with a copy to the opposite side. **However, no such application is traceable. Hence, the court cannot adjudicate on any such application.** Thus, the matter cannot be kept pending on an application which has not ever been taken on record.

Accordingly, matter is now fixed for **recording of S. A. u/s 313 Cr.P.C** on 13.08.2026.
