ORDER BELOW EXH.-1

The applicant viz. Pravin Sahadev Kasrung has filed application for releasing 1] Nutrip Anxicalm (2 Bottles), 2] Nutrip Asta Plus (2 Bottles), 3] Nutrip Coco plus (3 Bottles) and 4] Nutrip Green DHS (3 Bottles). The Investigating Officer, gave no objection for handing over the seized muddemal in favour of the applicant. Ld. A.P.P. submitted that the said muddemal will require for identification during the trial. It is prayed that, necessary order be passed.

2] Heard both sides.

3] During the investigation said medicines/Gym. products are recovered. It also appears that, as per the report lodged by present applicant, a crime bearing No.1448/2019, P.U.S. 379 of I.P.C., is registered against unknown accused, at police station, Bandra, Mumbai. In support of application applicant placed on record an invoice, which discloses that said medicines/Gym. products are purchased on 03/08/2019, by applicant from 1UP Lifecare Private Limited, Fort, Mumbai 23, for an amount of ₹7,836/- (Seven Thousand Eight Hundred and Thirty Six). Applicant also placed on record copies of his Aadhar Card, F. I. R. No purpose would be served by keeping the seized property at police station itself. Applicant is entitled for getting custody of medicines/Gym. products. Therefore, the order :

ORDER

- 1] The seized medicines/Gym. products i.e. 1] Nutrip Anxicalm (2 Bottles), 2] Nutrip Asta Plus (2 Bottles), 3] Nutrip Coco plus (3 Bottles) and 4] Nutrip Green DHS (3 Bottles), be given to the applicant viz. MR. Pravin Sahadev Kasrung, R/o.- Mahakali Darshan, Gondavale Gaothan, Azad Road, Building No.5, 3rd Floor, Room No.303, Andheri (E), Mumbai, on indemnity Bond of ₹10,000/- (Ten Thousand), which is to be executed before Investigating Officer of Railway Police Station, Bandra, Mumbai, on following condition :
 - (a) The applicant shall produce the said medicines/Gym. products, as and when required.
 - (b) The applicant shall not transfer or alienate the seized medicines/Gym. products till the decision of the main case.
 - (c) The applicant shall not change the nature of the seized medicines/Gym. products by any manner till the decision of the main case.
- 2] The Investigating Officer shall furnish the Indemnity Bond alongwith the final report / chargesheet, in this Court.
- 3] This proceeding be kept with the remand papers of C. R. No.1448/2019 of Railway Police Station, Bandra, Mumbai for merging the same in the main case after filing the chargesheet, if any.
