ORDER

Petitioners were granted anticipatory bail by this Court as per the order in Cr.M.P. No.1702/2026 dated 06.04.2026 with one of the conditions that, the petitioners shall appear and sign before the respondent police station daily at 10.00 A.M., until further orders.

The learned Counsel for the petitioners has submitted that, petitioners have been complying the condition regularly from 15.05.2026 with great hardship and that petitioners are the only breadwinners of their families and due to the observance of the condition, petitioners are unable to go to their daily work and so it is very difficult for the petitioners to observe the above condition and therefore, the said condition imposed upon the petitioners may be relaxed totally.

The learned Public Prosecutor has not raised any objection to relax the said condition imposed upon the petitioners.

Considering the above facts and circumstances of the case that, petitioners are abiding the said condition from 15.05.2026 and the learned Public Prosecutor has not raised any serious objection, this Court is inclined to relax the said condition imposed upon the petitioners.

In the result, this petition is allowed and the said condition imposed upon petitioners in Cr.M.P. No.1702/2026 dated 06.04.2026 with one of the conditions that,



the petitioners shall appear and sign before the respondent police station daily at 10.00 A.M., until further orders is totally relaxed.
