Petition u/s.483 BNSS is filed to grant bail to the petitioner.

This Petition has come up for final hearing before this court today, in the presence of Thiru.R.Muthuraj Advocate for the petitioner and the Inspector of Police, Maniyachi P.S. for respondent.

Heard both side.

ORDER

The petitioner is alleged to have committed offences on 13.04.2026 u/s. 103(1) @ 103(1), 191(1), 296(b), 3(5) of BNS. The petitioner was arrested and remanded to judicial custody on 27.04.2026.



The case of the prosecution is that, the petitioner and other co-accused had unlawfully assembled and involved in rioting, abused the deceased with filthy words and attacked the deceased with deadly weapons and murdered him.

The learned counsel for the petitioner has submitted that, the petitioner is an innocent and not at all committed any offence as alleged by the prosecution and that the petitioner is in judicial custody from 27.04.2026 for the past 67 days and due to accident this petitioner leg was broken and operation was done in his leg and continuously he is taking treatment at Tirunelveli Government Medical College Hospital as outpatient and that the co-accused was already released on bail and that the case has been charge sheeted in P.R.C. No.40/2026 and that the petitioner is ready and willing to furnish sufficient sureties for his release on bail and that therefore, the petitioner may be enlarged on bail.

The Inspector of Police, Maniyachi Police station has appeared before this court and stated that the case has been charge sheeted in P.R.C. No.40/2026.

The petitioner is in judicial custody for the past 67 days and there is no serious objection on the respondent side and the case has been charge sheeted in P.R.C. No.40/2026. Hence, considering the above facts and circumstances of the case, this Court is inclined to grant bail to the petitioner subject to the following conditions:

- i) The petitioner is ordered to be released on bail on executing a bond for Rs.10,000/- with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate, Ottapidaram
- ii) The petitioner shall appear and sign before the respondent police station daily at 10.00 A.M from the date of release for a period of 30 days,



iii) If the petitioner breaches any of the aforesaid conditions, the learned Judicial Magistrate is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed by the said officer as laid down by the Hon'ble Supreme Court in P.K.Shaji .vs. State of Kerala (2005 AIRSCW 5560),

iv) And if the petitioner, thereafter abscond, a fresh F.I.R may be registered against the petitioner u/s.269 of BNS.
