This Petition has come up for final hearing before this court today, in the presence of Thiru.G.Basker, Advocate for the petitioner and the Inspector of Police, Pudur P.S. for respondent.

ORDER

The petitioner was granted Bail by this Court as per the order in Cr.M.P. No.2742/2026 dated 05.06.2026 with one of the conditions that the petitioner shall appear and sign before the respondent police station daily at 10.00 A.M., until further orders.



The learned counsel for the petitioner has submitted that, the petitioner has been complying the condition regularly from 08.06.2026 with great hardship and the petitioner is a coolie and he is the only bread winner of his family and due to the observance of the condition, the petitioner is unable to go to his work and so it is very difficult for the petitioner to observe the above condition and therefore, the said condition imposed upon the petitioner may be relaxed totally.

The Inspector of Police, Pudur police station has appeared before this court and stated that the petitioner has been observing the condition from 08.06.2026.

Considering the above facts and circumstances of the case that the petitioner is abiding the said condition from 08.06.2026 and also considering the nature and gravity of the offence, this Court is inclined to modify the said condition imposed upon the petitioner.

In the result, this petition is partly allowed and the said condition imposed upon petitioner in Cr.M.P. No.2742/2026 dated 05.06.2026 is modified to the extent that, the petitioner shall appear and sign before the respondent police station once in 15 days on 1st and 16th day of every month at 10.00 A.M., until further orders and all other conditions in the said order remains unaltered.
