This Petition has come up for final hearing before this court today, in the presence of M/s.I.Durka Sankari, Advocate for petitioners and the Inspector of Police, Central P.S. for respondent.

Heard both side.



O R D E R

Petitioners were granted Bail by this Court as per the order in Cr.M.P. No.3830/2025 dated 31.10.2025 with one of the conditions that, petitioners shall deposit cash security of Rs.10,000/- (Rupees Ten thousand only) each (totally Rs.20,000/-) before the Judicial Magistrate Court No.II, Thoothukudi.

The learned counsel for the petitioner has submitted that the said condition has been modified to the extent that, the petitioners shall deposit cash security of Rs.1,000/- (Rupees One thousand only) each (totally Rs.2,000/-) before the Judicial Magistrate Court No.II, Thoothukudi as per the order in Cr.M.P. No.4253/2025 dated 15.12.2025 and that the petitioners are in custody from 15.10.2025 for the past 252 days and the petitioners are not able to deposit the said amount and it is very difficult for the petitioners to observe the condition and that therefore, the said condition imposed upon the petitioners may be modified to the extent that, the petitioners are ordered to be released on bail on own bond.

The Inspector of Police, Thoothukudi Central police station has appeared before this court and stated that the petitioner is in judicial custody from 15.10.2025.

Considering the facts and circumstances of the case and the fact that, the petitioners are in judicial custody from 15.10.2025 and the difficulties faced by the petitioner in observing the condition, this court is inclined to modify the said condition imposed upon the petitioner.

In the result, this petition is allowed and the said condition imposed upon the petitioner in Cr.M.P. No.4253/2025 dated 15.12.2025 is modified to the extent that, the petitioner is ordered to be released on bail on executing a own bond for Rs.10,000/- to



the satisfaction of the learned Judicial Magistrate No.II, Thoothukudi and all other conditions in the said order remains unaltered.
