Petition u/s.482 BNSS is filed to modify the condition imposed on petitioners.

This Petition has come up for final hearing before this court today, in the presence of Thiru.P.J.Jedidiah Koilson, Advocate for petitioners and the Inspector of Police, Kulasekarapattinam P.S. for respondent.

### **ORDER**

Petitioners were granted anticipatory bail by this Court as per the order in Cr.M.P. No.2468/2026 dated 27.05.2026 with one of the conditions that the petitioners shall appear and sign before the respondent police station daily at 10.00 A.M., until further orders.

The learned Counsel for the petitioner has submitted that, petitioners have been complying the condition regularly from 21.06.2026 with great hardship and that the petitioners are residing in different places and this is the second application for condition modification and the 1<sup>st</sup> application was dismissed as not pressed in Cr.M.P. No.3008/2026 and that the petitioners are coolie and they are the only bread winners of their family and due to the observance of the condition, petitioners are unable to go to their work and so it is very difficult for the petitioners to observe the above condition and therefore, the said condition imposed upon the petitioners may be modified to the extent that, the 1<sup>st</sup> to 3<sup>rd</sup> petitioners may be ordered to sign before the S10 Pallikaranai police station, Medavakkam, Chennai and



the 4<sup>th</sup> petitioner may be ordered to sign before the KR Pura police station, Krishnarajapuram, Bangalore.

The Inspector of police, Kulasekarapattinam police station has appeared before this court and stated that the petitioners are residing in Chennai.

On perusal of the petition, it is found that the 1<sup>st</sup> to 3<sup>rd</sup> petitioners are residing in Chennai and the 4<sup>th</sup> petitioner is residing in Thoothukudi. Hence, considering the above facts and circumstances of the case, this Court is inclined to relax the said condition imposed upon the 1<sup>st</sup> to 3<sup>rd</sup> petitioners and since the 4<sup>th</sup> petitioner is residing in Thoothukudi, this court is not inclined to relax the condition for the 4<sup>th</sup> petitioner.

In the result, this petition is allowed and the said condition imposed upon 1<sup>st</sup> to 3<sup>rd</sup> petitioners in Cr.M.P. No. 2468/2026 dated 27.05.2026 is modified to the extent that, 1<sup>st</sup> to 3<sup>rd</sup> petitioners shall appear and sign before the S10 Pallikaranai police station, Medavakkam, Chennai daily at 10.00 A.M., until further orders and all other conditions in the said Cr.M.P. remains unaltered and with regard to the 4<sup>th</sup> petitioner, this petition is hereby dismissed.
