Petition u/s.483 BNSS is filed to grant bail to the petitioner.

This Petition has come up for final hearing before this court today, in the presence of Thiru.M. Koil Pitchai, for the petitioner and the Inspector of Police, Muthiahpuram P.S. for respondent.

Heard both side.

ORDER

Petitioners are alleged to have committed offences on 26.06.2026 u/s.3(5), 296(b), 326(g), 351(3) of BNS. Petitioners were arrested and remanded to judicial custody on 27.06.2026.

The case of the prosecution is that, petitioners along with the co-accused abused the de-facto complainant with filthy language, thrown a bottle filled with petrol on the de-facto complainant's shop and also criminally intimidated the de-facto complainant.



The learned Counsel for the petitioner has submitted that, the petitioner is an innocent and not at all committed any offence as alleged by the prosecution and the petitioner is in judicial custody from 27.06.2026 for the past 7 days and due to previous motive false case has been registered and further stated that the marriage of the 1st petitioner's daughter who is the sister of the 2nd petitioner is to be held on 05.07.2026 and produced marriage invitation to prove his contention and that the petitioners are ready and willing to furnish sufficient sureties for their release on bail and that therefore, petitioners may be enlarged on bail.

The Inspector of Police, Muthiahpuram police station has appeared before this court and stated that a wordy altercation happened between the de-facto complainant and the petitioner regarding grazing of cows and the 1st petitioner is having two previous cases.

Considering the above facts and circumstances of the case and the fact that, petitioners are in judicial custody for the past 7 days and no serious objection raised on the respondent side, this Court is inclined to grant bail to the petitioners subject to the following conditions:

i) Petitioners are ordered to be released on bail on executing a bond for Rs.10,000/- each with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate No.II, Thoothukudi,

ii) Petitioners shall appear and sign before the Judicial Magistrate Court No.II, Thoothukudi on all working days at 10.30 A.M from the date of release for a period of 30 days,

iii) If the petitioners breaches any of the aforesaid conditions, the learned Judicial Magistrate is entitled to take appropriate action against the petitioners in



accordance with law as if the conditions have been imposed by the said officer as laid down by the Hon'ble Supreme Court in P.K.Shaji .vs. State of Kerala (2005 AIRSCW 5560),

iv) And if the petitioners, thereafter abscond, a fresh F.I.R may be registered against the petitioners u/s.269 of BNS.
