This Petition has come up for final hearing before this court today, in the presence of Thiru.S.Dalwin Kumar, Advocate for the petitioner and no representation on the respondent side.

ORDER

The petitioner was granted anticipatory bail by this Court as per the order in Cr.M.P. No.3020/2026 dated 18.06.2026 with one of the conditions that the petitioner shall appear and sign before the Judicial Magistrate Court No.I, Thoothukudi on all working days at 10.30 A.M., until further orders.



The learned counsel for the petitioner has submitted that, the petitioner has been complying the condition regularly from 22.06.2026 with great hardship and the petitioner is a coolie and he is the only bread winner of his family and and he working in Sathankulam due to the observance of the condition, the petitioner is unable to go to his work and so it is very difficult for the petitioner to observe the above condition and therefore, the said condition imposed upon the petitioner may be relaxed totally.

No representation on the respondent side.

Considering the above facts and circumstances of the case that the petitioner is abiding the said condition from 22.06.2026 for only 12 days and the difficulties faced by the petitioner in observing the condition, this Court is inclined to modify the said condition imposed upon the petitioner.

In the result, this petition is partly allowed and the said condition imposed upon petitioner in Cr.M.P. No.3020/2026 dated 18.06.2026 is modified to the extent that, the petitioner shall appear and sign before the Sathankulam Police Station daily at 10.00 A.M., until further orders and all other conditions in the said order remains unaltered.
