ORDER

The petitioner was granted bail by this Court as per the order in Cr.M.P. No.2640/2026 dated 27.05.2026 with one of the conditions that, the petitioner shall appear and sign before the respondent police station daily at 10.00 A.M., until further orders.



The learned counsel for the petitioner has submitted that, the petitioner has been complying the condition regularly from 01.06.2026 with great hardship and the petitioner is a woman and it is very difficult for the petitioner to observe the above condition and therefore, the said condition imposed upon the petitioner may be relaxed totally.

The Inspector of Police, Vilathikulam police station appeared before this court and stated that the petitioner has been complying the condition from 01.06.2026.

Considering the nature and gravity of the offence and the fact that, the petitioner is abiding the said condition from 01.06.2026 and the difficulties faced by the petitioner in observing the condition, this Court is inclined to modify the said condition imposed upon the petitioner.

In the result, this petition is allowed and the said condition imposed upon petitioner in Cr.M.P. No.2640/2026 dated 27.05.2026 is modified to the extent that, the petitioner shall appear and sign before the respondent police station weekly once on every Monday at 10.00 A.M., until further orders and all other conditions in the said Cr.M.P. remains unaltered.
