ORDER

The petitioner was granted bail by this Court as per the order in Cr.M.P. No.2570/2026 dated 20.05.2026 with one of the conditions that the petitioner shall appear and sign before the respondent police station daily at 10.00 A.M., until further orders.



The learned counsel for the petitioner has submitted that, the petitioner has been complying the condition regularly from 03.06.2026 with great hardship and the petitioner is a coolie and he is the only bread winner of his family and due to the observance of the condition, the petitioner is unable to go to his work and so it is very difficult for the petitioner to observe the above condition and therefore, the said condition imposed upon the petitioner may be relaxed totally.

The Inspector of police, Nazareth police station has appeared before this court and stated that the petitioner is observing the condition from 03.06.2026.

Considering the above facts and circumstances of the case that the petitioner is abiding the said condition from 03.06.2026 and since there is no serious objection on the respondent side, this Court is inclined to relax the said condition imposed upon the petitioner.

In the result, this petition is allowed and the said condition imposed upon petitioner in Cr.M.P. No.2570/2026 dated 20.05.2026 with one of the conditions that, the petitioner shall appear and sign before the respondent police station daily at 10.00 A.M., until further orders is totally relaxed.
