Petition u/s.483 BNSS is filed to relax the condition to petitioners.

This Petition has come up for final hearing before this court today, in the presence of Thiru.R.Rajasudalai, Advocate for petitioners and in the presence of the learned Public Prosecutor for prosecution.

Heard both side.

ORDER

Petitioners were granted anticipatory bail by this Court as per the order in Cr.M.P. No.3040/2026 dated 18.06.2026 with one of the conditions that the petitioners shall appear and sign before the respondent police station daily at 10.00 A.M., until further orders.

The learned Counsel for the petitioner has submitted that, petitioners have been complying the condition regularly from 25.06.2026 with great hardship and the petitioners are coolie and they are the only bread winners of their family and due to the observance of the condition, petitioners are unable to go to their work and so it is very difficult for the petitioners to observe the above condition and therefore, the said condition imposed upon the petitioners may be relaxed totally or modified.

The learned Public Prosecutor has raised objection to relax the said condition imposed upon the petitioners.



Considering the nature and gravity of the offence and the fact that, the petitioners are observing the condition only from 25.06.2026, this Court is not inclined to relax or modify the said condition imposed upon the petitioners.

In the result, this petition is hereby dismissed.
