Petition u/s.483 BNSS is filed to grant bail to the petitioner.

This Petition has come up for final hearing before this court today, in the presence of Thiru.M.Murugan, Advocate for the petitioner and the learned Public Prosecutor for prosecution.

Heard both side.

ORDER

The petitioner is alleged to have committed offences on 16.06.2026 u/s.132, 296(b), 351(3) of BNS and 25(1A) of Arms Act. The petitioner was arrested and remanded to judicial custody on 16.06.2026.

The case of the prosecution is that, the petitioner along with the co-accused have abused the de-facto complainant who is a public servant with filthy language, deterred him from discharging his duty and also criminally intimidated with weapon.



The learned counsel for the petitioner has submitted that, the petitioner is an innocent and not at all committed any offence as alleged by the prosecution and that the petitioner is in judicial custody from 16.06.2026 for the past 36 days and in most of the previous cases the petitioner has been acquitted and the petitioner has been regularly appearing before the concerned court in all pending cases and that the petitioner is ready and willing to furnish sufficient sureties for his release on bail and that therefore, the petitioner may be enlarged on bail.

The learned Public Prosecutor has raised strong objection to release the petitioner on bail by stating that, totally two accused in this case and this petitioner is the 1st accused and he is having 21 previous cases.

Even though the learned Public Prosecutor has raised strong objection, since this petitioner is in judicial custody for the past 36 days and as per the representation of the petitioner counsel, this petitioner is regularly appearing before the concerned court in all pending cases, this Court is inclined to grant bail to the petitioner subject to the following stringent conditions:

i) The petitioner is ordered to be released on bail on executing a bond for Rs.10,000/- with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate No.III, Thoothukudi,

ii) **The petitioner shall stay in Tirunelveli and appear and sign before the Tirunelveli town police station daily at 10.00 A.M from the date of release for a period of 30 days,**

iii) If the petitioner breaches any of the aforesaid conditions, the learned Judicial Magistrate is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed by the said officer as laid



down by the Hon'ble Supreme Court in P.K.Shaji .vs. State of Kerala (2005 AIRSCW 5560),

iv) And if the petitioner, thereafter abscond, a fresh F.I.R may be registered against the petitioner u/s.269 of BNS.
