Petition u/s.483 BNSS is filed to grant bail to the petitioner.

This Petition has come up for final hearing before this court today, in the presence of Thiru.S.Karuppasamy, Advocate for the petitioner and the learned Public Prosecutor for prosecution.

Heard both side.

ORDER

The petitioner is alleged to have committed offences on 06.11.2025 u/s.103(1) of BNS. The petitioner was arrested and remanded to judicial custody on 07.11.2025.

The case of the prosecution is that, the petitioner along with the co-accused have murdered the deceased.



The learned counsel for the petitioner has submitted that, the petitioner is an innocent and not at all committed any offence as alleged by the prosecution and that the petitioner is in judicial custody from 07.11.2025 for the past 256 days and in the mean time, this petitioner was detained under Goondas Act and the same was revoked by the Hon'ble High Court in H.C.P. (MD) No.717/2026 and this is the 2nd application for bail and 1st application was already dismissed by this Court in Cr.M.P. No. 4214/2025 dated 15.12.2025 and that the petitioner is ready and willing to furnish sufficient sureties for his release on bail and that therefore, the petitioner may be enlarged on bail.

The learned Public Prosecutor has raised strong objection to release the petitioner on bail by stating that this case has been made over to the 1st Additional District and Sessions Court, Thoothukudi.

Considering the objection raised by the learned Public Prosecutor that, this case has been made over to the 1st Additional District and Sessions Court, Thoothukudi, this court is not inclined to allow this petition and the petitioner is directed to seek remedy before the proper court.

In the result, this petition is hereby dismissed.
