This Petition has come up for final hearing before this court today, in the presence of Thiru.J.Joseph Zinoson, Advocate for the petitioner and the learned Public Prosecutor for prosecution.

O R D E R

The petitioner is alleged to have committed offences on 03.07.2026 u/s.420, 465, 467, 468, 471 IPC r/w 109, 34 IPC. The petitioner was arrested and remanded to judicial custody on 04.07.2026.

The case of the prosecution is that the petitioner along with the co-accused have created forged document, used the forged document as a genuine one and thereby cheated the de-facto complainant.

The learned counsel for the petitioner has submitted that, the petitioner is an innocent and not at all committed any offence as alleged by the prosecution and that the petitioner is in judicial custody from 04.07.2026 for the past 17 days and no specific overtact against this petitioner and this petitioner's name is not mentioned in the F.I.R. and most part of investigation was over and this petitioner is in custody in another case and formally arrested in this case on 04.07.2026 and that the petitioner is ready and willing to furnish sufficient sureties for his release on bail and that therefore, the petitioner may be enlarged on bail.

The learned Public Prosecutor has raised strong objection to release the petitioner on bail by stating that, the investigation is still pending and therefore, custody of this petitioner is required for further investigation.

The petitioner is in custody in another case and already having similar cases. In this case, investigation is in the earlier stage and the learned Public Prosecutor is seeking custody of this petitioner for further investigation. Hence, considering the



above facts and circumstances of the case and nature and gravity of the offence, this court is not inclined to grant bail to the petitioner.

In the result, this petition is hereby dismissed.
