ORDER

The petitioner was granted anticipatory bail by this Court as per the order in Cr.M.P. No.2657/2026 dated 27.05.2026 with one of the conditions that the petitioner shall appear and sign before the respondent police station daily at 10.00 A.M., until further orders.



The learned Counsel for the petitioner has submitted that, the petitioner has been complying the condition regularly from 10.06.2026 with great hardship and the petitioner is a coolie and he is the only bread winner of his family and due to the observance of the condition, the petitioner is unable to go to his work and so it is very difficult for the petitioner to observe the above condition and therefore, the said condition imposed upon the petitioner may be relaxed totally.

The learned Public Prosecutor has not raised any objection to relax the said condition imposed upon the petitioner.

Considering the above facts and circumstances of the case that the petitioner is abiding the said condition from 10.06.2026 and the learned Public Prosecutor has not raised any serious objection, this Court is inclined to relax the said condition imposed upon the petitioner.

In the result, this petition is allowed and the said condition imposed upon petitioner in Cr.M.P. No.2657/2026 dated 27.05.2026 with one of the conditions that the petitioner shall appear and sign before the respondent police station daily at 10.00 A.M., until further orders is totally relaxed.
