This Petition has come up for final hearing before this court today, in the presence of Thiru.E.Gururaj Advocate for the petitioner and the learned Public Prosecutor for prosecution.

O R D E R

The petitioner is alleged to have committed offences on 10.07.2026 u/s.296(b), 115(2), 351(3) of BNS and Section 3 of TNPPDL Act. The petitioner was arrested and remanded to judicial custody on 11.07.2026.

The case of the prosecution is that, the petitioner along with co-accused have abused the de-facto complainant with filthy language, assaulted and caused injuries and criminally intimidated the de-facto complainant and also damaged the motor cycle seat cover and mirror

The learned counsel for the petitioner has submitted that, the petitioner is an innocent and not at all committed any offence as alleged by the prosecution and that the petitioner is in judicial custody from 11.07.2026 for the past 10 days and in fact that, the petitioner and the de-facto complainant are close friends and due to wordy quarrel while drinking liquor false case has been registered and the de-facto complainant was discharged from the hospital and this petitioner is admitted in Thoothukudi Government Medical college hospital and totally three accused in this case and this petitioner is A2 and that the petitioner is ready and willing to furnish sufficient sureties for his release on bail and that therefore, the petitioner may be enlarged on bail.

The learned Public Prosecutor has raised strong objection to release the petitioner on bail by stating that, totally three accused in this case and this petitioner is the 2nd accused and the damage value is Rs.20,000/- and this petitioner is having 5 previous cases.

Considering the nature and gravity of the offence and the criminal antecedents of the petitioner and since the investigation is in the earlier stage, if this petitioner is



enlarged on bail, there is every possibility of tampering the witness and hampering the investigation, this court is not inclined to grant bail to the petitioner.

In the result, this petition is hereby dismissed.
