Petition u/s.483 BNSS is filed to grant bail to the petitioner.

This Petition has come up for final hearing before this court today, in the presence of Thiru.R.Muthuraj Advocate for the petitioner and the learned Public Prosecutor for prosecution.

Heard both side.

ORDER

The petitioner is alleged to have committed offences on 03.07.2026 u/s.123 BNS and Section 25(1) of COTPA Act. The petitioner was arrested and remanded to judicial custody on 03.07.2026.



The case of the prosecution is that, the petitioner along with the co-accused were in illegal possession of 15 pockets of tobacco products for sale.

The learned counsel for the petitioner has submitted that, the petitioner is an innocent and not at all committed any offence as alleged by the prosecution and that the petitioner is in judicial custody from 03.07.2026 for the past 18 days and due to statistical purpose false case has been registered and this is the 2nd bail application and the earlier bail application was dismissed by this court in Cr.M.P. No.3514/2026 dated 09.07.2026 and no previous case against this petitioner and that the petitioner is ready and willing to furnish sufficient sureties for his release on bail and that therefore, the petitioner may be enlarged on bail.

The learned Public Prosecutor has raised strong objection to release the petitioner on bail by stating that, totally two accused in this case and this petitioner is the 1st accused and the accused persons were in illegal possession of 15 packets of Ganesh tobacco products in their bag and further stated that this is the 2nd bail application and no previous case against this petitioner.

The petitioner is in judicial custody for the past 18 days. Properties were seized by the respondent and no previous case against this petitioner. This is the 2nd bail application and the earlier bail application was dismissed by this court on 09.07.2026. Hence, considering the above facts and circumstances of the case and since the learned Public Prosecutor has not raised any serious objection, this Court is inclined to grant bail to the petitioner subject to the following conditions:

i) The petitioner is ordered to be released on bail on executing a bond for Rs.10,000/- with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate No.I, Kovilpatti,



ii) The petitioner shall appear and sign before the respondent police station daily twice a day at 10.00 A.M and 05.00 P.M. from the date of release until filing of charge sheet,

iii) If the petitioner breaches any of the aforesaid conditions, the learned Judicial Magistrate is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed by the said officer as laid down by the Hon'ble Supreme Court in P.K.Shaji .vs. State of Kerala (2005 AIRSCW 5560),

iv) And if the petitioner, thereafter abscond, a fresh F.I.R may be registered against the petitioner u/s.269 of BNS.
