Petition u/s.483 BNSS is filed to modify the condition to the petitioner.

This Petition has come up for final hearing before this court today, in the presence of Thiru.A.Sathya, Advocate for the petitioner and the learned Public Prosecutor for prosecution.

Heard both side.

ORDER

The petitioner was granted Bail by this Court as per the order in Cr.M.P.No.3420/2026 dated 04.07.2026 with one of the conditions that, the petitioner shall deposit cash security of Rs.1,00,000/- (Rupees One Lakh only) before the Judicial Magistrate Court No.II, Thoothukudi (the amount, if deposited, shall be kept by the above Judicial Magistrate Court in Criminal court Deposit a/c. till the disposal of the case).



The learned counsel for the petitioner has submitted that the petitioner is in custody from 15.06.2026 and that the petitioner has completed his under graduation in the year of 2026 and has not find out any job to support his family of five members including his parents and the petitioner's father is a sole bread winner of the family and for the above said reasons, the petitioner is unable to deposit the security amount and the co-accused has been granted bail on payment of Rs.5,000/- as security. Under the above circumstances, the condition imposed upon the petitioner may be modified.

The learned Public Prosecutor has not raised any objection to relax the condition imposed upon the petitioner.

Conditions the submissions made by the learned counsel for the petitioner and the fact that there is no serious objection from the respondent side, this court is inclined to grant the petition. Accordingly, the condition imposed in Cr.M.P. No.3420/2026 dated 04.07.2026 is modified to the extent that, the petitioner shall deposit cash security of Rs.50,000/- (Rupees Fifty Thousand only) before the Judicial Magistrate Court No.II, Thoothukudi (the amount, if deposited, shall be kept by the above Judicial Magistrate Court in Criminal court Deposit a/c. till the disposal of the case) and all other conditions in the said Cr.M.P. remains unaltered.
