The present application has been presented before this Court for attestation and acceptance of personal and surety bonds in pursuance of the order dated 07.08.2026 in B.A. no. 1282 of 2026 and Reg. no. 195 of 2026 of Ld. Special Judge, POCSO, Mandi, District Mandi, H.P. The certified copy of order has been annexed with the application. In pursuance of order of Ld. Special Judge, POCSO, Mandi, District Mandi H.P. the applicant is ordered to be released on bail subject to furnishing personal and one surety bonds in the sum of Rs. 40,000/- and to the following conditions:

1. that the applicant/accused shall make himself available before the Court till the conclusion of the trial and regularly attend the court proceeding.
2. that the applicant/accused shall not tamper with the prosecution evidence in any manner whatsoever and not cause any threat/harassment to the victim or her family.
3. that the applicant/accused shall not make any inducement, threat or promises to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the Court.
4. that in case applicant/accused indulges in repetition of similar offence then his bail shall be liable to be canceled on taking appropriate steps by the prosecution/victim.

5. that the applicant/accused shall not leave the territory of India without prior permission of the court.

6. that the applicant/accused shall inform the police/court, his contact number and shall keep on informing about change in address and contact number, if any, in future.

7. that the applicant/accused shall absolutely refrain from his presence at or near the vicinity of the house, work place of the child victim.

The personal and surety bonds as directed furnished. The surety bond is accepted by me today. Since, the accused is reported to be lodged in District Jail Mandi, H.P. accordingly, the Jail Superintendent of the said Jail is directed to attest the personal bond and release the accused person, if not required in any other case. The requisite bonds after needful be submitted before this Court forthwith. Application stands disposed of. Release order be prepared immediately. These papers be tagged with the concerned record.
