This Petition has come up for final hearing before this court today, in the presence of Thiru. N.Mahesh Saravanan, Advocate for the petitioner and the learned Public Prosecutor for prosecution.

ORDER

The petitioner has been granted bail by this Court as per the order in Cr.M.P. No.2104/2026 dated 27.04.2026 with one of the conditions that the petitioner shall appear and sign before the respondent police station daily at 10.00 A.M., until further orders.

The learned Counsel for the petitioner has submitted that, the petitioner has been complying the condition regularly from 01.05.2026 with great hardship and the petitioner is a coolie and he is the only bread winner of his family and due to the



observance of the condition, the petitioner is unable to go to his work and so it is very difficult for the petitioner to observe the above condition and therefore, the said condition imposed upon the petitioner may be relaxed totally.

The learned Public Prosecutor has not raised any objection to relax the said condition imposed upon the petitioner.

Considering the nature and gravity of the offence and the difficulties faced by the petitioner in observing the condition, this Court is inclined only to modify the said condition imposed upon the petitioner.

In the result, this petition is partly allowed and the said condition imposed upon petitioner in Cr.M.P. No.2104/2026 dated 27.04.2026 is modified to the extent that, the petitioner shall appear and sign before the respondent police station weekly twice on every Monday and Thursday at 10.00 A.M., until further orders and all other conditions in the said Cr.M.P. remains unaltered.
