**ORDER EXH. 1**

This is an application for recovery of gratuity in form No. 3 as per the Rule 19 of Payment of Gratuity Rules, 1972.

In earlier proceeding bearing number P. G. A. 223/2017, this Court has ordered the payment of gratuity along with interest over it. The said order is not complied by the Non-applicants in this proceeding. Non-applicant No. 1, 2 and 4 appeared through their advocates but non-applicant No. 1 and 4 have not filed their reply to this application. Non-applicant No. 2 filed reply at Exhibit-9. Perused the record of the case. Heard advocates for both sides. This is defenseless proceeding. Non-applicants are bound to pay the amount of gratuity to applicant as per the direction of the Court. Hence, the following order.

**ORDER**

1. Issue recovery certificate to The Collector, of Yavatmal in prescribed form for recovery of amount of Rs. 41,792/- (Rs. Forty One Thousand Seven Hundred Ninety Two Only) to the applicant along with interest @ 5% per annum from the date of filing of application till the actual realization of the amount.
2. The applicant to submit his affidavit regarding the movable and immovable property of the non-applicants.
3. The proceeding stands disposed off.
