This case referred to the Lok-Adalat organized by the Taluk Legal Services Committee, Tirupathur, Under Section 19 of the Legal Services Authorities Act, 1987 (Act 39 of 1987) coming on before us for endeavors for settlement of dispute between parties being the subject matter of this case, in the presence of the parties and their counsel, and after a full and frank discussion of all issues factual and legal arising from the case, the parties having agreed before us that there shall be award/order/decree in terms of settlement hereto made and their Counsel herein having, in acceptance of the same, signed this in our presence, this Adalat doth order and decree:

AWARD

1. Petitioner claimed at Rs. 25,00,000 = /- as compensation for the fatal/injury caused to him/her in the Motor Vehicle Accident. The parties have agreed for full and final Settlement for Rs. 12,50,000 = /- (Rupees Twelve lakhs Fifty Thousand only) Hence the award is passed in accordance with Sec 21 of Legal Services

Authorities Act, 1987. 2nd Respondent shall deposit the Award amount within 30 days from the date of settlement of this award into the Courts' Account. Name of the Court Special Sub Court (MD) Tirupathur.

3. Minor petitioner's award amount shall be deposited in any one of the Nationalized Bank till the minor attains Major.
4. In default of the Respondent No. 2, he shall pay interest for the decree amount at the rate of 7.5 per annum from the date of settlement till the date of payment of the entire amount.
5. Both the parties to this settlement are entitled to file separate applications before the court where the claim petition is now pending for the follow up action if any, as and when necessary arises.
6. The Court fee paid if any shall be returned to the claimant as per the Rules.
7. The award is passed amicably.
