Decree

1. That the suit is decreed.
2. That the Defendant is directed to pay the suit amount of Rs.1,00,270/- to the Plaintiff Bank with interest at the rate of 13.55% p.a. on Rs.1,00,000/- from the date of filing the suit (30.06.2023) till the realization. Within 3 months.
3. That the Defendant has to pay cost of Rs.5,704/- to the Plaintiff.
