This petition came up before this Court for hearing moved by Mr. P. Rajeshkumar, Advocate, for the petitioner/accused and Mr. D. Manivannan, Public Prosecutor for the State and upon perusing the petition and reply, this Court passes the following:-

**ORDER**

This petition had been filed by the petitioner under section 483 of Bharatiya Nagarik Suraksha Sanhita to grant bail with regard to the case in Crime Number 90/2020 of Muthupettai Police Station for the offence mentioned as punishable under sections 212, 399 of IPC.

2. According to the petitioner, he had been remanded to judicial custody on 02.01.2026 by the above said complainant, to execute the NBW warrant issued by the Judicial Magistrate, Thiruthuraipoondi on 02.01.2026. In the above said case in S.C. No. 55/2025 and charge sheet had been filed punishable under sections 212, 399 of IPC against the petitioner / accused. He is innocent person and not guilty of any offences in the above said case allegedly framed against him. He is only bread-winner of the family. If the petitioner had released on bail, he will abide by any terms and conditions of this Court. The petitioner is ready to furnish sufficient sureties and hence seeks to grant bail to the petitioner.

3. Whereas the Public Prosecutor had submitted the reply of Respondent / Complainant in which it is stated that the NBW Warrant issued by the Judicial Magistrate, Thiruthuraipoondi on 02.01.2026 against the petitioner and had been remanded to judicial custody on 02.01.2026 and two previous cases in Cr. No. 201/2023 on the file of Nolambur Police Station, Chennai and Cr. No. 59/2017 on the file of Pattukottai Taluk Police Station are pending against the petitioner. If the accused let on bail, he will abscond to other state, he will involve in similar offence and hence strongly objected to let the accused on bail.

4. Reply received and perused. Heard. Considering that the petitioner is a history sheeter in H.S. No. 587/2020 and A<sup>+</sup> Rowdy and considering the nature and gravity of offence and considering the investigation is premature stage and strong objection of prosecution and considering other circumstance of the case, this Court is not inclined to grant bail to the petitioner.

5. In the result, this petition is dismissed.
