DECREE

1. That the suit be and the same is hereby decreed,
2. That the defendant is hereby directed to pay a sum of Rs.10,00,000/- to the plaintiff as on the date of institution of the suit and to pay with subsequent interest at 12% for the principal amount of Rs.10,00,000/- from the date of the suit till the date of decree and to pay the interest at 6% from the date of decree till the date of payment or realization in full and
3. That the defendant is hereby directed to pay a sum of Rs.42664/- towards cost of the suit to the plaintiff.
