In connection with the above subject matter, the applicant preferred said application before the Hon'ble court to get Muddamal money, which was freeze U/s. 102 of Cr.Pc. The court is ordered as under

Order

The application u/s. 457 of Criminal Procedure Code is hereby allowed. It is order to return the cash amount of **Rs.6600/-** which was seized in connection with the above-mentioned offence, shall be returned to the present applicant as interim custody, on furnishing surety and personal bond of one and a half sum of seized amount in concerned police station, subject to the following conditions and **till** the final disposal of the case.

It is further ordered that, as per the order of the court, on furnishing the surety and personal bail bond in the police station by the applicant, the police officer have to inform about the said process as well as informed regarding the order of the court to the concerned bank. It is also ordered to the bank that, after receiving the information from the police office about the order of the court as well as information regarding to comply process of surety and personal bond, the total amount of **Rs.6600/-** which is deposited in the **Rs.6600/- in the Account No: 50100503527074 OF HDFC BANK** has to be transferred and deposited to the applicant's **A/c. No. 40663114868 of SBI BANK**. The bank is directed to inform about the comply of order to the Court and concerned police station within 10 days, after receiving the information of court order from the police station.

Terms: -

1. The applicant will have to produce the said amount before this Hon'ble when court ordered it.
2. If the above-mentioned account holder or any other person made claims about the said amount and proves his interest, in those circumstances, the applicant will have to return the said amount.
3. The said muddamal amount should not be used or allowed to be used for any criminal purpose.
4. In the event of breach of any of the condition, the interim order stands automatically cancelled and the muddamal amount shall be confiscated again and the surety and amount of bail bond shall be recovered.

According to the above order, regarding to return the seized Muddamal amount to the applicant, and inform about order of the court to the concerned bank after obtain Surety and personal bail bond and executing the order and send the necessary bond to the court without fail.

It is further directed to the police officer in charge that, at the time of giving above intimation to the concerned bank, the following information must be mentioned.

"The concern bank should confirm that the alleged amount is deposited in the account of the accused from the bank account of the applicant and the concern bank shall return. The amount in the same account from which it has been deposited in the account of the accused in their bank"
