This petition is coming before me for hearing today in the presence of Thiru.M.Sudhakar, learned counsel for the petitioner, the learned Public Prosecutor for the respondent and, after hearing both sides, this court, delivered the following:

O R D E R

This is a petition for modification of the condition imposed on the petitioner in Cr.M.P.No.743 of 2026, dated 03.03.2026 for the offences u/s. 296(b), 115(2), 118(1), 109(1), 351(3) of BNS.

2. Heard both sides. Considered their submissions and perused the papers.
3. This is the petition to modify the bail conditions imposed on the petitioner by this in Crl.M.P. No. 743 of 2026 dated 03.03.2026 with condition that the petitioner is ordered to be enlarged on bail on executing a bond for a sum of

Rs.25,000/-, before the Judicial Magistrate, Katpadi along with two sureties, and both sureties shall be blood relatives of the petitioner and shall produce title deed to show their means. The petitioner is not able execute the bail order, because he does not have a surety as blood relatives to capable of standing as surety with property documents. Hence, the said condition has become practically impossible to comply with. But the petitioner is ready to produce 3rd party sureties. Hence the petitioner prays to modify the condition from blood relation surety to normal surety. Further the petitioner is ready and willing to comply with all other condition imposed by this court.

4. The learned Public Prosecutor left the matter to the discretion of this court.
5. Considering the submissions made by the learned counsel for the petitioner, and in view of circumstances stated in the petition, this court is of the view that the condition requiring the blood relatives sureties alone is modified to normal sureties.
6. In the result, this petition is allowed and the bail conditions imposed in CrI.M.P.No. 743 of 2026 dated 03.03.2026, condition No. 7(a) alone is modified as hereunder

The petitioner is ordered to be enlarged on bail on executing a bond for a sum of Rs.25,000/- before the Judicial Magistrate, Katpadi along with two sureties and both the sureties shall produce title deed to show their means.

7. In all other aspects, the condition imposed earlier shall remain unaltered.
