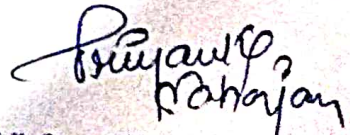

IN THE MATTER OF:- Application for directing I/C, PS Reasi to register the date of birth particulars of the applicant's son in the birth record register.

Order

1. The instant application has been moved by the applicant for the registration of date of birth of the applicant's son in the concerned register. The applicant has stated that applicant is the resident of above-mentioned address who got married to Sushma Kumari and one male child were born to them at home. But due to some domestic problem at that time he could not get it required and the same now required to be registered in the records. Hence this application in hand. The applicant has annexed a photocopy his Aadhar card and Grade Card (Class 10th) of his wife. An affidavit duly sworn in has also been attached herewith along with a vakalatnama.
2. In view of the application report from the concerned police station was sought. The report suggested that the date of birth of the applicant's son was not registered with them in register of Births and Deaths.
3. In order to invite objections from general public, a proclamation to this effect was published in newspaper early times dated 19/10/2022. Despite the publication no one appeared in the court to file any objections within the stipulated time in the publication.
4. In support of application, the applicant has produced evidence in the form of his own statement which stands recorded in the court along with the

statement of the witness namely Koushalya Devi W/o Inder Singh R/o Village Gran More Tehsil and District Reasi who was the Panch of village Gran More Tehsil & District Reasi and Pawan Kumar S/o Desu R/o Village Gran More Tehsil & District Reasi. The witness has deposed in the support of applicant's contention. The statement of the applicant and the witnesses stands duly recorded and made part of the file.

5. From the deposition of applicant and other witnesses in the support of applicant, the date of birth of the applicant's son was sufficiently proved but due to the reason mentioned above the same could not be entered in the police records. There is nothing on record to reject the contentions of the application of the applicant. Thus there is no hitch in passing the direction for recording the birth particulars of the applicant's son as such: –

 - ii) Mother's name:- Sushma Kumari
 - iii) Date of birth:- 22-05-2010
 - iv) Age:- about 12 years
 - v) Place of birth:- At home
6. As such I/C PS Reasi is directed to record the date of birth particulars of applicant's son as mentioned above in his official records. Office is directed to furnish a copy of this order to I/C concerned for its compliance under the rules.
7. This direction, is, however binding on the non-applicant I/C police station Reasi only and does not confer any citizenship right or state Subject entitlement or to any compensation to the applicant.
8. Application accordingly is disposed of and consigned records after its due compilation under the rules.
