This is a suit for recovery of money to pass decree directing the defendants to pay a sum of Rs.1,35,700/- on principal amount of Rs.1,00,000/- with subsequent interest at the rate of 12% p.a. from the date of plaint till realization and pay the cost of the suit.

The plaint was presented on 17.04.2025.

Valuation of the suit is Rs.1,35,700/- and a Court Fees of Rs.4,071/- has been paid under Section 22 of the Tamil Nadu Court Fees and Suit Valuation Act 1995.

The causes of action suit arose at Villupuram District, Vikkiravandi Taluk, Athiyur Thirukkai Village on 25.04.2022, 10.03.2025 and subsequently.

This suit having been taken on file on 17.04.2025 and came up for final hearing on 05.03.2026 in the presence of Tr.S.A.Sangeethkumar, learned Advocate on behalf of the Plaintiff and defendants called absent set exparte, upon perusing the case records, upon hearing arguments of Plaintiff side and having been stood over for consideration till this date, this court doth order and decree as follows:

**DECREE**

1. that the suit is decreed with costs.
2. that the directing the defendants are jointly and severally liable to pay a sum of Rs.1,35,700/- together with interest at 9% per annum on principal amount of Rs.1,00,000/- from the date of filing of the suit to till this date and at 6% on the principal amount from the date of decree till realization.
3. that the defendants do pay plaintiffs a sum of Rs.6,035/- towards the cost of the suit.
